

## Instructions for Completing Application for Temporary (Construction) Water Meter

**General Instructions:** Careful attention to providing the required application information expedites the FLORIDA GOVERNMENTAL UTILITY AUTHORITY (FGUA) review process and enables it to respond within a **10-working day time frame**. Furthermore, the information provided by applicants is needed to calculate and notify them of impact and connection fees due.

**Specific Instructions:** All items must be fully answered or furnished. Answers may be described in detail on continuation sheets, if necessary, and referred to on the application.

- Item 1: Specify full legal name and address of the property owner(s).
- Item 2: Mark appropriate box describing the project
- Item 3: Provide the FGUA Project Number for the project.
- Item 4: Specify name of the project.
- Item 5: Mark the appropriate box describing applicant, if the applicant is a general contractor or owner of the commercial entity
- Item 6: Mark appropriate boxes describing how the temporary meter be installed. It is preferred that the temporary meter is installed on a nearby fire hydrant. Field personnel will verify whether or not a fire hydrant is available, and then and only then will the temporary construction meter be installed with a construction gap
- Item 7: Indicate the type of project being constructed
- Item 8: Specify approximate date temporary water service will be required
- Item 9: Specify the date when the new construction is expected to be completed.
- Item 10: Specify the street address of the location where service is requested.
