

Florida Governmental Utility Authority (FGUA)

**Schedule of Water and Wastewater Charges for Mad Hatter
Service Area of Consolidated System**

A. The following provisions shall apply to the service designations included herein as follows:

1. Residential Service shall mean service to all individually metered residential customers including, but not limited to, private residences, apartments units, condominiums, and mobile homes.
2. General Service shall mean service for all purposes including all commercial service and master-metered commercial service, industrial service, and any other service not classified as Residential Service.

B. The following are the monthly water and wastewater rates for service to the Foxwood Lakes, Turtle Lakes, Linda Lakes, and Paradise Lakes service areas designated at the time of acquisition by the FGUA (the "Mad Hatter Area"), as may be amended from time to time by the FGUA:
