

**Florida Governmental Utility Authority (FGUA)**

**Schedule of Water and Wastewater Charges for North Fort Myers (NFM) System**

**A. The following provisions shall apply to the service designations included herein as follows:**

1. Residential Service shall mean service to all individually metered residential customers including, but not limited to private residences, apartment units, condominiums, and mobile homes.
2. Multi-Residential Service shall mean service to all master-metered residential customers including, but not limited to condominiums, apartments, and mobile home parks. Multi-Residential Service shall be billed on a per unit basis including facility charges. A unit shall mean a residential dwelling unit or lot on which a dwelling unit or similar structure is situated, including a recreational vehicle space.
3. Bulk Service shall mean service provided by contract or agreement on a sale for resale basis.
4. General Service shall mean service for all purposes including commercial service and master-metered commercial service, industrial service, and any other service not classified as Residential Service, Multi-Residential Service, or Bulk Service.
5. Unless specifically provided, all wastewater consumption charges will be based on metered water consumption at the premises exclusively of any separately metered water-only use as adjusted per FGUA policy.

**B. The following are the monthly water and wastewater rates for service to the Pine Lakes and Lake Fairways service area as designated at the time of acquisition by the FGUA (the "Pine Lakes Area"):**
