Existing and Proposed Water and Wastewater Rates

A. The following provisions shall apply to the service designations included herein as follows:

- 1. Residential Service shall mean service to all individually metered residential customers including, but not limited to, private residences, apartment units, condominiums, and mobile homes.**
- 2. General Service shall mean service for all purposes including all commercial service and master-metered commercial service, industrial service, and any other service not classified as Residential Service.**

E. The Monthly Base Charge as shown shall represent the minimum bill. All utility accounts, including Inactive Utility Accounts, shall be charged the Monthly Base Charge.

F. All bills for utility services shall be rendered monthly.
